A. RECOMMENDATION:

THAT The Board of Library Commissioners:

1. Approve the transfer of funds in the amount of \$500,000 from Salaries, General Account 1010 to Salaries, Overtime Account 1090 within the Library's Fiscal Year 2025-26 Budget, Fund 300, Department 44.

B. FINDINGS:

1. The Library uses full-time employees on an overtime basis to staff public and support service desks, to fill-in for vacancies, or when there are staff shortages due to employee illness, vacation or jury duty. When necessary, the Library transfers funds between its salary accounts to ensure there are sufficient funds in the appropriate accounts.
2. Sufficient funds are available in Account 1010 Salaries, General for this transfer.
